**NOTICE TO PROPERTY OWNERS
CONFIRMATION OF HEARING EXAMINER'S REPORT**

In accordance with the provisions of Act 246 of the Public Acts of 1931, as amended, an application by petition was received by the Board of County Road Commissioners of the County of Oakland initiating the improvement of **FOXFIRE DRIVE, HUNTCLIFF COURT, MYSTIC HILLS DRIVE, and ROLLING GREEN COURT**, platted in Mystic Hills Estates, Section 20, Milford Township; **FOXFIRE DRIVE**, located in Mystic Knolls Condo, Section 20, Milford Township, Oakland County, Michigan, referred to as **S.A.D. No. 12003**. Attached is a copy of a resolution adopted by the Board, which **confirms** the proposed determination of the Hearing Examiner for the Hearing on Objections.

If the property owners of record of more than 50% of the lineal frontage of the streets to be improved desire to have the Board reconsider its determination, they may submit a petition for Reconsideration to the Secretary/Clerk of the Board within ten (10) days after this mailing. This Petition must be filed no later than **MAY 16, 2022**. Upon receipt of a qualifying petition, the Board will set a time and place for a hearing and give notice as required by the authorizing statute. At the conclusion of the hearing, the Board may modify or confirm its previous determination; the determination shall thereupon be final.

Reconsideration petition forms are available upon request at the Road Commission office; if none are received, the project will proceed and a bid letting date established.

WHEREAS, Pursuant to Act 246, Michigan State Statute for the year 1931 as amended and in accordance with the provisions of a resolution adopted by this Board under date of April 7, 2022, Robert S. Rollinger as Hearing Examiner, did conduct a public Hearing on Objections for FOXFIRE DRIVE, HUNTCLIFF COURT, MYSTIC HILLS DRIVE, and ROLLING GREEN COURT, platted in Mystic Hills Estates; FOXFIRE DRIVE, located in Mystic Knolls Condo; all located in Section 20, Milford Township, Oakland County, Michigan. The purpose of this hearing being to hear objections to the proposed improvement, the plans and specifications, estimates of cost, the establishment of the boundaries of the proposed special assessment district or the parcels and lots which may be liable to assessment, the apportionment of the percentage of the total cost of the proposed improvement, the number of installments in which the money for the assessments shall be raised and to determine whether the proposed improvement is necessary for the benefit of the public and for the public welfare and convenience; and

WHEREAS, this Board has reviewed the said Findings of Fact and Proposed Determination of the Hearing Examiner.

NOW, THEREFORE, BE IT RESOLVED, that this Board hereby **confirms** the Findings of Fact and Proposed Determination of said Hearing Examiner; and

BE IT FURTHER RESOLVED, that in accordance with the provisions of Act 246, this Board hereby reconfirms their previous determination that the proposed improvements are necessary for the benefit of the public and for public welfare and convenience and that improvements be made to the aforementioned streets.
