**NOTICE TO PROPERTY OWNERS
VALID PETITION**

The Board of County Road Commissioners of the County of Oakland has passed a resolution declaring the petition "**VALID**" as submitted by affected property owners of lands touching or fronting on **IRIS DRIVE (platted as Island Drive), platted in Mountain View Country Club**, Section 6, Waterford Township, Oakland County, Michigan, referred to as **S.A.D. No. 23265**. This petition requests that this street be paved by means of a special assessment to the benefiting property owners.

In accordance with the provisions of Act 246 of the Public Acts of 1931, State of Michigan, as amended, a Public Hearing on Objections will be scheduled at a future date. All affected property owners will be duly and properly notified as to the date, time, and location for this Hearing and will be given an opportunity to express their objections to or support for the proposed improvement.

COPY OF RESOLUTION ADOPTED BY THE
BOARD OF COUNTY ROAD COMMISSIONERS
OF THE COUNTY OF OAKLAND, MICHIGAN,
UNDER DATE OF JUNE 16, 2022

WHEREAS, IRIS DRIVE (platted as Island Drive), platted in Mountain View Country Club, Section 6, Waterford Township, Oakland County, Michigan, is a public street under the jurisdiction of the Board; and

WHEREAS, on May 6, 2022, the Board of County Road Commissioners received an application by petition for a Special Assessment Road Improvement Project; and

WHEREAS, as provided by Act 246, Michigan State Statute for the year 1931 as amended, this petition was circulated to obtain more than 51% of the lineal footage of lands fronting or touching each of the described street said frontages being certified as Iris Drive - 53.195%.

NOW, THEREFORE, BE IT RESOLVED, that pursuant to Act 246, the application by petition for a Special Assessment Improvement Project for each of the described street has been found to be VALID; and

BE IT FURTHER RESOLVED, that this Board hereby makes its preliminary determination that the proposed improvement is necessary for the benefit of the public and is for public welfare and convenience; and

BE IT FURTHER RESOLVED, this Board directs the necessary surveys be made, grades established, plans and specifications prepared along with the related estimates of cost of the project. This Board also directs that a plat of lands to be assessed be made showing all lands that may be benefited by the proposed improvements; and

BE IT FURTHER RESOLVED, that this Board hereby orders that a copy of this resolution shall be served by First Class Mail to each owner of, or party in interest in property to be assessed, at their address as shown upon the latest local tax records.
