Background:

The RCOC utilizes Disposable Paper Products agency-wide for office use and janitorial mechanic clean up.

Financial Considerations:

A solicitation was issued through the MiTN (Michigan Inter-Governmental Trade Network). Forty-eight (48) vendors downloaded bid documents, and twenty-one (21) suppliers submitted responses. Of those responses, seven (7) suppliers met the minimum order requirements.

It is recommended that contracts be awarded to the lowest responsive and responsible suppliers meeting specifications, offering firm-fixed annual pricing, and maintaining low minimum order requirements, as summarized below:

Staples Contract & Commercial LLC

- 4 items (see tabulations)
- Annual Estimated Total: \$20,028.00
- Pricing: One-year firm-fixed
- Minimum Order: \$50
- Delivery: 3–5 days

Armorex (formerly Tri-County Supply)

- 1 item (see tabulations)
- One-time purchase
- Total: \$1,435.00

Recommendation:

I recommend that the Board approve contracts with Staples Contract & Commercial LLC in the amount of \$20,028.00 and Armorex in the amount of \$1,435.00, for a total annual estimated contract amount of \$21,463.00.

SUBJECT: DISPOSABLE PAPER PRODUCTS - IFB NO. 7732

216 suppliers were notified of the above-listed solicitation. 48 solicitation documents were downloaded from the MiTN (Michigan Inter-Governmental Trade Network) site. 21 suppliers responded.

Of the 21 responses, ten suppliers offered firm-fixed annual term pricing. Of those ten responses, seven suppliers required minimum order requirements.

It is recommended the contract be awarded to the overall low suppliers meeting specifications, offering firm-fixed annual pricing, and low minimum order requirements:
