**NOTICE TO PROPERTY OWNERS  
HEARING ON DECLARATION OF NECESSITY**

In accordance with the provisions of Act 246 of the Public Acts of the State of Michigan for the year 1931, as amended, West Bloomfield Township adopted a resolution, making an application to the Board of County Road Commissioners of the County of Oakland initiating the improvement of **APPOLINE DRIVE, DAINTREE AVENUE** (platted as Druley Avenue), **LAKESHIRE DRIVE, LANGHAM DRIVE** (platted as Lake View Drive), **PUTNAM DRIVE, and SUNNY CREST DRIVE**, platted in Herndon's Walnut Lake Estates, Sections 24 and 25, West Bloomfield Township, Oakland County, Michigan, referred to as **S.A.D. No. 24230**.

Attached is a copy of a resolution adopted by the Board of County Road Commissioners of the County of Oakland, which makes a determination and declaration of necessity for the improvement and provides for a public Hearing on the Declaration of Necessity to be held on, **NOVEMBER 25, 2019 at 7:00 p.m. at the West Bloomfield Township Hall, 4550 Walnut Lake Road, West Bloomfield, Michigan**.

Act 246 also provides a method by which a project initiated by the township may be discontinued. Property owners representing 51% or more of the abutting total lineal frontage of above named streets may submit a petition requesting the project be discontinued to the Board of County Road Commissioners of the County of Oakland. These petitions must be submitted within 45 days after the date of the public hearing. Discontinuance Petitions will be available at the Road Commission offices after the public hearing.

You, as a concerned citizen and property owner, are cordially invited to attend this hearing. Please call (248) 645-2000, extension 2270, for further information. If you require accommodation in accordance with the provisions of the Americans with Disabilities Act (ADA) or provisions within Title VI, including those requiring language assistance and / or special accommodations, the Road Commission for Oakland County (RCOC) will provide such services, free of charge, with reasonable advance notice (7 business days) to the RCOC. COPY OF RESOLUTION ADOPTED BY THE BOARD OF  
COUNTY ROAD COMMISSIONERS OF THE COUNTY OF  
OAKLAND, MICHIGAN, UNDER DATE OF NOVEMBER 7, 2019

WHEREAS, **APPOLINE DRIVE, DAINTREE AVENUE (platted as Druley Avenue), LAKESHIRE DRIVE, LANGHAM DRIVE (platted as Lake View Drive), PUTNAM DRIVE, and SUNNY CREST DRIVE, platted in Herndon's Walnut Lake Estates, Sections 24 and 25, West Bloomfield Township** are public streets under the jurisdiction of the Board; and

WHEREAS, this Board has received an application by resolution of the West Bloomfield Township Board dated October 8, 2019, requesting the determination be made that it is necessary for the benefit of the public and for public welfare and convenience that the aforementioned streets be improved; and

WHEREAS, this application by resolution complies with the provisions of Act 246 of the Public Acts of 1931, State of Michigan, as amended, and as provided in the Policy and Procedure Manual for Special Assessment Projects as adopted by the Board.

NOW, THEREFORE, BE IT RESOLVED, that this Board does hereby receive, accept and acknowledge the resolution of the Township Board and does hereby determine and declare it is necessary for the benefit of the public and is for public welfare and convenience that improvements be made to the aforementioned streets; and

BE IT FURTHER RESOLVED, that in accordance with the provisions of Act 246, a public Hearing on the Declaration of Necessity shall be held on the 25th day of November 2019, at 7:00 p.m., at the West Bloomfield Township Hall, 4550 Walnut Lake Road, West Bloomfield, Michigan, and;

BE IT FURTHER RESOLVED, said Hearing on the Declaration of Necessity shall be conducted by a Hearing Examiner and shall be limited to consideration of whether the proposed project is necessary for the benefit of the public and is for public welfare and convenience; and

BE IT FURTHER RESOLVED, that this Board does hereby appoint Thomas R. Charboneau, Jr. of 2041 E. Square Lake Road, Troy, Michigan to act as Hearing Examiner for said Hearing and at all subsequent Hearings held for the improvement of the aforementioned streets except when the Hearings are conducted by the Board itself; and

BE IT FURTHER RESOLVED, that said Hearing Examiner shall submit findings of fact and proposed determinations to the Board in accordance with the Policy and Procedure Manual for Special Assessment Improvement Projects; and

BE IT FURTHER RESOLVED, parcels of land, **lots numbering 17 and 21 through 386, inclusive, platted in Herndon's Walnut Lake Estates Subdivision; and lot 486 platted in Herndon's Walnut Lake Estates No. 1 Subdivision, Sections 24 and 25, West Bloomfield Township**, may be subject to assessment for benefits accruing from the proposed improvement; and

BE IT FURTHER RESOLVED, that notice of this Hearing shall be given in accordance with Act 246 and that this Board hereby orders that a copy of this resolution shall be served by First Class mail to each owner of, or party in interest in property to be assessed, at their address as shown upon the latest local tax records.
