**NOTICE TO PROPERTY OWNERS
INVALIDITY OF RECONSIDERATION PETITION**

The Board of County Road Commissioners of the County of Oakland has passed a resolution declaring the reconsideration petition **INVALID** as submitted by affected property owners of lands touching or fronting on **COLONY HEIGHTS BOULEVARD, LISA CIRCLE, and LISA COURT, platted in Colony Heights No. 1; LISA CIRCLE, MELINDA CIRCLE, MELINDA CIRCLE EAST and SHARON DRIVE, platted in Colony Heights No. 2; MELINDA CIRCLE, MELINDA CIRCLE EAST and SHERRY DRIVE, platted in Colony Heights No. 3, Section 25, White Lake Township, Oakland County, Michigan, referred to as S.A.D. No. 25062.**

Due to the invalidity of the reconsideration petition, the project will continue in the process to establish a Special Assessment paving project. Property owners will be notified by first class mail as to the date of the next hearing.

BOARD OF COUNTY ROAD COMMISSIONERS
OF THE COUNTY OF OAKLAND, MICHIGAN,
UNDER DATE OF APRIL 9, 2020

WHEREAS, pursuant to Act 246, Michigan State Statutes for the year 1931, as amended and in accordance with the provisions of a resolution adopted by this Board under date of February 6, 2020, Robert S. Rollinger as Hearing Examiner, conducted a public Hearing on Objections in Light of Increased Costs on March 3, 2020, for the purpose of hearing objections as to whether the proposed improvement of COLONY HEIGHTS BOULEVARD, LISA CIRCLE, and LISA COURT, platted in Colony Heights No. 1; LISA CIRCLE, MELINDA CIRCLE, MELINDA CIRCLE EAST and SHARON DRIVE, platted in Colony Heights No. 2; and MELINDA CIRCLE, MELINDA CIRCLE EAST and SHERRY DRIVE, platted in Colony Heights No. 3, Section 25, White Lake Township, Oakland County, Michigan, is necessary for the benefit of the public and for public welfare and convenience; and

WHEREAS, the Hearing Examiner, did file with this Board on March 12, 2020, a report containing Findings of Fact and Proposed Determinations; and

WHEREAS, this Board did reconfirm the Findings of Fact and Proposed Determination of the Hearing Examiner by resolution of the Board under date of March 19, 2020, and also reconfirmed their previous determination that the proposed improvements are necessary for the benefit of the public and for public welfare and convenience; and

WHEREAS, a Reconsideration Petition has been circulated by property owners of record who desire to have the Board of Oakland County Road Commissioners reconsider its previous determination; and

WHEREAS, Act 246 of PA 1931 as amended requires that said petition must contain signatures of property owners representing more than 50% of the total lineal frontage along the proposed improvement, and be filed with this Board within ten (10) days after mailing of copies of the Board's confirmation of the Hearing Examiner's report; and

WHEREAS, said petition was filed within the ten (10) day reconsideration period and contained signatures of property owners representing 3,912.66 feet or 29.53% of the lineal frontage along the proposed improvement.

NOW, THEREFORE, BE IT RESOLVED, that a Petition for Reconsideration has been found to be INVALID in that insufficient signatures were obtained; and

BE IT FURTHER RESOLVED, that this Board does hereby order that this project proceed in accordance with Act 246; and

BE IT FURTHER RESOLVED, that this Board hereby orders that a copy of this resolution shall be served by First Class Mail to each owner of, or party in interest in property to be assessed, at their address as shown upon the latest local tax records.
