REMINDER: RESURFACING PROJECT ON 12 MILE ROAD FROM GREENFIELD TO COOLIDGE IN THE CITY OF BERKLEY SET TO BEGIN JUNE 1

Beverly Hills, MI – The Road Commission for Oakland County (RCOC), in partnership with the City of Berkley, will begin a resurfacing project on 12 Mile Road from Greenfield Road to Coolidge Highway on Monday, June 1.

During the first stage, 12 Mile Road will close to through traffic from Greenfield Road to Ellwood Drive for approximately one month for more extensive repairs of this section. During the closure, the detour route for traffic will be Greenfield Road to 11 Mile Road to Coolidge Highway, back to 12 Mile Road and vice versa.

Beginning in late June, the south half of 12 Mile Road will be resurfaced, with traffic shifted onto the north half of the road.

Pedestrian and business access will be maintained throughout the project.

The approximately \$2.8 million project is 80 percent funded with federal dollars with the remaining costs shared by the City of Berkley, RCOC and Oakland County general government (through the Tri-Party Program).

The 1.05-mile project includes:

- Milling (removing existing surface) and paving with three inches of asphalt
- More extensive repairs of 12 Mile Road between Greenfield Road and Ellwood Drive
- Reconstruction of side-street approaches to 12 Mile Road (residential access maintained)
- Americans with Disabilities Act (ADA)-compliant pedestrian crosswalks
- Pedestrian-signal upgrades
- New curbs and gutters

- Drainage improvements
- New signs and pavement markings

The second stage will begin as soon as the first stage is complete and will involve resurfacing the north half of the road, with traffic shifted onto the south half. With the exception of the one-month closure during the first stage, two-way traffic will be maintained on 12 Mile Road for the remainder of the project.

Work on 12 Mile Road will be suspended during the Woodward Dream Cruise scheduled for Aug. 13- 17.

12 Mile Road construction is expected to be complete in the late fall. The contractor for the project is Pro-Line Asphalt of Washington Township.

This section of 12 Mile Road carries approximately 15,500 vehicles per day. For more information on the 12 Mile project, visit: <http://www.rcocweb.org/537/12-Mile-Road-Greenfield-to-Coolidge>.
